Who Can Apply?
 An eligible applicant should be an agency of the appropriate Government or a body corporate. Body Corporate should fulfil the following eligibility criteria:

- (a) In case of a company - The entity should have a minimum of Rs. 3 crores in paid-up capital.
- (b) In case of a partnership/proprietorship firm - the partners should have invested minimum of Rs. 5 crores in the Partnership as shown in the partnership deed.
- The entity should have a minimum of Rs. 50 crores of net worth.
- Should not exceed 49% of its capital.

Process of Becoming Digital Locker Service Provider

- Applicant will build their digital locker service in conformance to the Digital Locker Technology Framework and security and procedural guidelines published by DLA.
- Applicant will submit DLSP Licence application to Digital Locker Authority (DLA).
- DLA will examine the application to ascertain eligibility as per the eligibility criteria.
- Post-acceptance of eligibility, Standardisation Testing and Quality Certification Directorate (STQC) will undertake audit of the applicant's infrastructure as per the Framework & guidelines published by DLA.
- On successful audit, Licence to be granted by DLA as per laid down procedure.
